Sacramento County Draft Redistricting Plans Released

Citizen input encouraged online and at community workshops

Registrar of Voters Jill LaVine announced today that five draft redistricting plans are now available for Sacramento County residents to view and make comments online. The plans will also be presented at community workshops held throughout the County. To see the draft plans online, dates and locations of the community workshops, and maps of existing districts, visit www.elections.saccounty.net/Redistricting.

LaVine encourages residents to provide input on the draft plans. "Public comments will be included in our recommendations to the Board of Supervisors as the final district lines are being drawn. The adopted plan will be implemented for elections beginning in 2012."

Every 10 years, after the U. S. Census, Sacramento County must redraw supervisorial district lines to ensure the five districts are as equal in population as possible. "Each plan submitted must take into consideration several factors such as political or geographical boundaries, communities of interest, and cultural, ethnic and socio-economic similarities," said LaVine.
