Txij li thaum pib siv qhov kev pov npav no-excuse xa hauv tsev xa ntawv nyob rau xyoo 2002 los, cov neeg pov npav xa hauv tsev xa ntawv mus yeej muaj coob zuj zus txog li 64% ntawm tag nrho lub nroog cov pej xeeb uas tau mus sau npe pov npav rau kev xaiv tsa.

Tom qab muab tus qauv Vote Center Model ntawm no los siv nyob rau Lub Rau Hli 2017, lub chaw Sacramento County Voter Registration and Elections (VRE) tau tsa muaj pawg neeg Voting Accessibility Advisory Committee (VAAC) thiab pawg neeg Language Accessibility Advisory Committee (LAAC). Ob pawg neeg ntawm no tau muab ntau lub tswv yim zoo los pab qhov chaw VRE thiab yuav yog ib cov neeg tseem ceeb rau kev dhia dej num hauv kev xaiv tsa rau lub nroog mus ntxiv tom ntej.

Qhov chaw VRE npaj los mus muab nws qhov kev qhia txog kev pov npav xaiv tsa nthuav mus qhia kom cov pej xeeb paub txog tus qauv Vote Center Model thiab cov cib fim uas lawv yuav mus nqis tes pab tau lub zej zos. Txoj kev npaj ntawm no muaj kev koom tes los ntawm ntau lub koom haum thiab muaj kev pab los ntawm lawv yuav yog ib qho tseem ceeb los muab tus qauv Vote Center Model rau kev xaiv tsa siv tau zoo nyob rau hauv lub Nroog Sacramento.
